One year into the COVID-19 pandemic, how did Eastern Partnership countries experience its disruptive effect pervasive across various aspects of life and policy?

Given the overlap between the end of the implementation of the 20 Deliverables for 2020 and the historical COVID-19 crisis, the EaP CSF policy papers series on the effects of COVID-19 offers a well-researched perspective over several thematic areas ranging from media freedom and digital literacy to labour migration and waste management. Covering essential questions that may have had a different answer - unless irreversibly disrupted by the current pandemic's staggering effects - our analysis provides EU and EaP stakeholders, strategists, civil society and media with thematic and regional insights and policy recommendations.

The Launch Event consisting of 3 panels will bring together authors, experts and stakeholders both on stage and in the audience aiming at highlighting the silver linings that the pandemic presents - opportunities and policy solutions - that should and could be harnessed in the Eastern Partnership during and beyond the pandemic.

The panel will feature the EaP CSF **framework policy paper - COVID-19 as potential for change in the EaP countries**, which sums up main regional and thematic trends from seven papers and provides an overarching regional and country-focused policy recommendations and solutions that can still be incorporated into the EaP roadmap for the period of 2021-2025. The discussion will be illustrated with case studies, examples, and good practices from the region as well as from additional policy areas.

Which trends in responding to the major crisis can be identified across the EaP countries? How to maximize the synergy effect of future policy solutions based on the experience from this crisis? In which areas can the COVID-19 impact effectively boost the modernization and reforms in the EaP countries?

Panel 3: Media freedom and digital literacy during and beyond COVID-19 pandemic in the EaP region
